
Department of Political and Peacebuilding Affairs (DPPA)



- Central role in UN efforts to prevent and resolve deadly conflicts
- Focus areas in international peace and security:
 - Ensuring sound analysis and early warning
 - Preventing conflict and engaging in peacemaking
 - Managing political crises and violent conflicts
 - Sustaining peace
 - Enhancing partnerships
- Monitors global political developments to detect potential crises
- Provides support to SG and his envoys to help defuse crises



Peacebuilding Support Office



Security Council Affairs Division







- Provides Secretariat functions for UNSC
- Supports UNSC subsidiary organs:
 - Committees: Counter-Terrorism, Sanctions, WMD, Military Staff
 - Working groups: Documentation and Procedures
 - Specific entities: ICTY, ICTR
- Provides advisory and research services to UNSC on practice and procedure

Electoral Assistance Division





- UN Focal Point for Electoral Assistance
- Provided on request of MS or mandated by UNSC or GA
- Tailored to specific needs of the country
- Objective, impartial, neutral and independent
- Provides political and technical guidance to all UN entities involved in Electoral Assistance

Policy and Mediation Division





- Preventive Diplomacy: envoys dispatched to crisis areas to encourage dialogue and the peaceful resolution of tensions
- Mediation: provides operational support to peace and dialogue processes

• **Peacemaking:** working with regional organisations to bring ongoing conflicts to an end, and to prevent new crises from emerging or escalating

Division for Palestinian Rights


- Supports the Committee on the Exercise of the Inalienable Rights of the Palestinian People

Decolonisation Unit

- Monitors the 17 remaining Non-Self-Governing Territories' political, economic and social developments

- Advises and supports the Special Committee on Decolonization






- Shared function with DPO
- Three Offices
 - Office of the ASG for Africa
 - Office of the ASG for Europe, Central Asia and the Americas
 - Office of the ASG for Middle East, Asia and the Pacific
- First point of contact with UNHQ from the Field Mission leadership
- All PKO and SPM are overseen by the respective geographic divisions

Director for Coordination and Shared Services



• Supports both DPPA and DPO: financial, personnel, and administration responsibilities



- Contributes to Peacekeeping Situation Centre (SITCEN) as part of UN Operations and Crisis Centre (UNOCC)
- Monitors leadership requirements in Peace Operations
- Manages media relations
- Provides Policy and Strategy on Safety and Security measures related to Peace Operations



- DPPA plays a central role in UN efforts to prevent deadly conflict and build sustainable peace
- Monitors and assesses global political developments to detect potential crises and devise effective responses
- Provides support to the SG and appointed envoys in their peace initiatives, as well as to UN political missions
- Cooperates with regional organisations on the frontlines of conflicts
